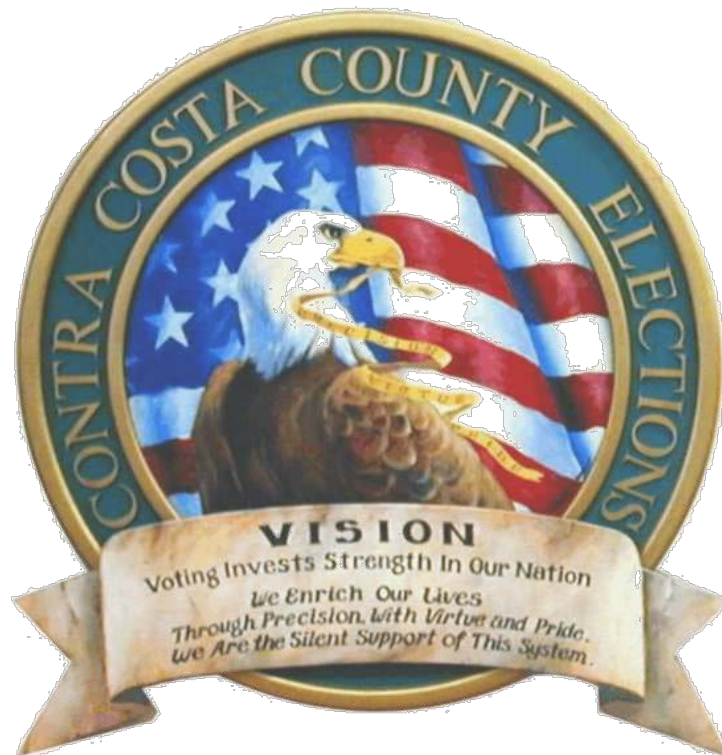

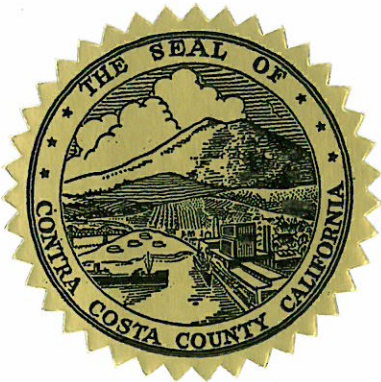

1% Manual Tally - June 4, 2013

Pursuant to Elections Code 15360, Contra Costa Elections Division conducted a 1% manual tally of precinct results for the June 4, 2013 Special Election. Notice of the drawing of precincts was given by press release and posted in the office lobby and on our website one week prior to the date of the random selection.

The random selection of precincts was conducted in the Elections Division lobby on Thursday, June 6, 2013 at 10:00 am. A ten-sided die was used to select the precinct to be fully tallied (1).

Votes cast, which were reported in the semi-final official canvass on election night, were tallied for each precinct selected; this included both precinct ballots and vote by mail ballots. A preliminary canvass report (statement of vote) by precinct was available to the public the day after the election for review or purchase.
