**Signatures In-Lieu of Filing Fee Period**  
**September 12 – November 6, 2019**

If an incumbent does not file by the nomination deadline [December 6, 2019], the seat is extended 5 calendar days [December 11, 2019], to non-incumbents only.

There is no extension period for vacant positions or term limited offices.
